**SPECIFIC PROCUREMENT NOTICE**

**ORISSA STATE ROADS PROJECT  
INTERNATIONAL COMPETITIVE BIDDING**

1. The Government of Orissa through the Government of India has applied for a loan from the International Bank for Reconstruction and Development (IBRD) in various currencies towards the cost of Orissa State Roads Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for following Civil Works Packages.
2. The Chief Engineer, World Bank Projects, Orissa on behalf of the Government of Orissa now invites sealed bids from eligible bidders for the construction and completion of following Civil Works defined in the table below. ("the Works").
3. Bidding will be conducted through the International competitive bidding procedures specified in the World Bank's Guidelines: *Procurement under IBRD Loans and IDA credits, (May 2004)* and is open to bidders from all countries as defined in the guidelines.
4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the address mentioned below.
5. A complete set of bidding documents in English language may be purchased by interested bidders on the submission of a written application to the addressed below and upon payment of a non-refundable fee as mentioned against each Civil Works in the table below with effect from **31<sup>st</sup> October, 2007**. A pre-bid meeting shall be held on **21<sup>st</sup> November, 2007** in the office of the undersigned at 11.00 Hours.

The Bid Documents can be downloaded from Official website of Orissa State Roads Project at <http://osrp.gov.in>. In case of downloaded document, the undersigned will not be responsible if any portion of the bid document is modified / omitted and in such cases the original document kept with in the office of the undersigned shall prevail. Bid documents downloaded from the website shall accompany with a non-refundable fee of **Rs. 10,400/-** towards cost of bid document in shape of a demand draft from any scheduled Bank of India in favour of the undersigned payable at Bhubaneswar.

6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Documents: Procurement of Works*.
7. Bidders are permitted to submit bids for one or both of the packages (see Table below). Multi-package rebate(s) offered, shall be considered in evaluation. Based on such evaluation, award of contract(s) would be made to one or more bidder(s) for one or both package(s) on the basis of least evaluated cost to the Employer. Bids must be delivered to the addressed below on or before **16 :00 Hours on 17<sup>th</sup> December, 2007** and must be accompanied by a security of amount mentioned against the works mentioned below. Late bids will be rejected. Bid must be delivered in the respective Tender Boxes having Identification No. **OSRP-CW-ICB-Y1-P01** or **OSRP-CW-ICB-Y1-P02** as the case may be.
8. Bids will be opened in the presence of bidders' representatives who choose to attend at **16.30 hours on 17<sup>th</sup> December, 2007** in the chamber of the Chief Engineer, World Bank Projects, Orissa at the address mentioned below.


